**CHECKLIST FOR SCHENGEN VISA - TOURISM OR VISITING FAMILY / FRIENDS** 

- All documentation has to be submitted either in the Greek or English language.
- Applicants will be required to submit their biometrics (fingerprints, digital photo) at the time of application.
- The Embassy reserves the right to ask for additional documents.
- The applicant may be requested to appear in the Embassy for interview.
- For children registered in parent's passport, a separate application form has to be submitted.
- Visa processing time at the Embassy will be approximately 15 working days.
- Submitting an application without the complete set of documentation according to the above checklist may result to the rejection of the visa application.
